Ricky,

I appreciate the follow up, and I do have hard evidence on the use of tax dollars to literally bribe DAs not to investigate and prosecute insurance companies or their employees. Police Depts. and the Attorney General's Office knows about it, and protects the scheme from investigation while literally thousands of citizens lose their insurance benefits.

However, I am more interested in why nothing is being done about the Oceanside Police, Firemen, Council Members, and their public unions criminally conspiring to tamper with an election to increase their pay and benefits. Or, the involvement of large numbers of Oceanside Police suppressing investigations, and tampering with evidence in large numbers of criminal prosecution with multiple DAs.
