GTI News will wait a reasonable period of time, while the investigation of the State Bar continues, to see public action by the Bar against Bar Attorney Members involved in public corruption crimes, of which you have already received public record documentation. The evidence shows the State Bar, and it's employees has been actively suppressing public record documentation of felony crimes by Bar members for more than two years.

Mr. Bossert,

As you are already aware, the Marugg document has the names of more than one attorney. For example, that of Richard Castle, and the defense attorney conspiring with his client, and the DA's Office, to obstruct justice does not limit the Bar's obligations, under the law to just Marugg. It is interesting that when the Bar had the documentation on DDA Marugg, Richard Castle, and others in 2012, no action was taken, and Marugg simply resigned again, as you said.

The article on Judge Maino, as per our discussions, was also to guide you to the actions of DDA Anna Winn in the Sgt. McWilson conspiracy, and DDA Daniel Rodriguez evidence tampering in the Shields case, and the Shippee case. Rodriguez "resigned" when caught, just like DDA Marugg, and the DA's office is currently scrambling to protect DDA Anna Winn from arrest, for conspiring with Judge Maino, and Det. Mike Brown in the McWilson case. DDA Rodriguez was obstructing justice, and hiding evidence in two different criminal prosecutions at the same time.
