Below are the two articles we discussed.

From 2008 and continuing today the DA 's office, DA Dumanis, and DDA Laura Gunn has been conspiring to manipulating the criminal courts and civil courts, and suppressing investigations of police and DA evidence tampering to protect themselves from a \$20 million dollar law suit, and possible criminal charges connected to the new trial order for Cynthia Sommer. One of those DA docs we talked about is a confidential memo between Dumanis and Gunn in April 2008 describing how the arsenic poison evidence used to convict Sommer never existed. What Dumanis, Gunn, and the DA's office did with that info is called criminal conspiracy to obstruct justice. The court records, linked in the article, show that after the memo was written, they obstructed the full dismissal of the case to stop Sommer's attorney from subpoenaing the DA's records, and to obstruct the deposing of the lead prosecutor Larua Gunn. They also did not want any of the evidence tampering info involving DDA Gunn, DDA Rodriguez, and the Oceanside Police Officers to get into the hands of Sommer's attorneys, as supporting evidence that could be used against Dumanis, Gunn, and the DA's office in that law suit. Gunn and Rodriquez both quickly and quietly resigned, and the DA's office dropped all complaints and obstructed all investigations.

The second document showed up in a attorney client communication document between DDA Marugg's attorney and the DA's office. Just like in the Gunn and Rodriguez criminal complaints and investigations, a deal was worked out with the DA's office to drop the criminal investigation of Marugg, and protect him from future investigations, if he would quietly resign. That is also criminal conspiracy to obstruct justice, and it is in writing. The document includes an agreement to obstruct any future State Bar investigations.

Chief McCoy received and obstructed all complaints of Oceanside police evidence tampering by officers Smith and Domonique, who were both directly connected to DDA's Gunn and Rodriguez evidence tampering, during the same time period that McCoy was ordering Officer Garcia to destroy more audio tape evidence, and obstructing the criminal investigation of Sgt Larson's DUI. All of this was occurring while the Oceanside police and firefighter election fraud conspiracy was underway, and all complaints to McCoy and the PD were suppressed.
